

**WEIYE HOLDINGS LIMITED**

**PROCEDURES FOR A SHAREHOLDER TO PROPOSE  
A PERSON FOR ELECTION AS A DIRECTOR OF  
THE COMPANY (A “DIRECTOR”)**

Weiye Holdings Limited (the “Company”) adopts a formal, considered and transparent procedure for shareholders to propose a person for election as a Director. The following procedures are subject to the Company’s articles of association, Singapore Companies Act (Chapter 50) and applicable legislation and regulation:

- If a shareholder, who is duly qualified to attend and vote at the general meeting convened to deal with the appointment or election of Director(s), wishes to propose a person (other than himself/herself) for election as a Director at that meeting, he/she may deposit a written notice at the Company’s registered office at 8 Pandan Crescent #01-06, Singapore 128464 or the Company’s principal office at 11th Floor, No. 50 Yingxie Road, Jinshui District, Zhengzhou City, Henan Province, PRC, for the attention of the Company Secretary of the Company.
- In order for the Company to inform all shareholders of that proposal, the written notice must state (i) his/her intention to propose such person for election as a Director and (ii) the biographical details of such nominated candidate as required under Rule 13.51(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (“Listing Rules”) for publication by the Company and be signed by the shareholder concerned and the person who has been proposed indicating his/her willingness to be elected.
- The period for lodgment of the above notice shall be at least seven (7) days and that the period for lodgment of such notice(s) shall commence no earlier than the day after the dispatch of the notice of the general meeting appointed for such election and end no later than seven (7) days prior to the date of such general meeting.
- Upon receipt of the above notice from a shareholder which is received after publication of the notice of general meeting, the Company shall, prior to the general meeting, publish an announcement or issue a supplementary circular disclosing the particulars of the proposed Director pursuant to Rule 13.51(2) of the Listing Rules.
